## **MATTERS ARISING**

## **PARISH BOUNDARY**

## **TELEPHONE KIOSK - Pennymoor**

The clerk reported that the red telephone box located outside Cruwys Arms had become more and more dilapidated of the years with the door falling off in recent high winds.

On contacting BT it was established that they are still required to maintain these kiosks and rely on being told when there is problem. The telephone is still in operation by use of credit/debit cards only.

BT will be sending someone shortly to look at the kiosk and arrange for its repair and hopefully a paint.

## **HIGHWAY PROBLEMS**

The following highway problems were reported:

- 1. Large pothole between Penfolds and North Coombe (not in parish) on the Way Village to Cadeleigh road.
- 2. On the bend opposite the parish hall the road has dropped away and continues to worsen.
- 3. The edge of the corner of the road at Mudfordgate Cross continues to get worse as more heavy vehicles use this turn off. This has been reported several times to Devon CC.
