effects of efficiency measures and wanted to consult with Parish Councils. **The Clerk** would forward the consultation questions to Councillors.

5/11/15 Road and Footpaths

- 5.1 Outstanding Road and Footpath issues
 - I. Traffic speeding in the village An e-mail had been received from PCSO Lisa Crocker who had indicated that she may attend the meeting. It was agreed to defer this item until later in the meeting.
 - II. Poor road surface on the main road at the junction of Silverway and The Village reported to DCC noted as assessed on 19 March. **Clerk to e-mail** Cllr M Squires
 - III. Footpath 3: Stile through holly hedge at the top of the hill from Great Gutton, broken lefthand upright needs replacing. The Footpath Warden had met with Ros Davies (DCC) who will contact the landowner to arrange for a gate to replace the stile at no cost to the Parish Council
 - IV. Footpath 5: Damaged waymarker post at the southern end near Lower Coombe needs replacing Footpath Warden to submit cost
 - V. Footpath 6: The two large gateposts on the northern side of the stream at the midpoint of this path are loose and the posts need to be tightened up. Footpath Warden to action

- VI. Footpath 7: Excessive vegetation on the track north of Moor Farm limits access. Letter sent to landowner and track now cleared remove from list
- VII. Footpath 13: Two hand rails are needed at the southern end where it drops down onto Church Lane on hold until after Footpath consultation
- VIII. Footpath 15: There are ongoing issues relating to access through this fenced footpath. Cllr R Steer had contacted the owner who will undertake the maintenance. Clerk to email Cllr R Steer the guidance available from DCC re responsibilities of land owners. Remove from list.
 - IX. Footpath 22: The broken post in the gateway to the path opposite Shute Farm entrance needs to be fixed or replaced. Robert Ayre to action
- X. Footpath 57: Damaged waymarker Clerk to contact land owner
 5.2 Permissive path at allotments

5.2a Update on installation of stone chippings/hardcore inbetween the two small gates Cllr J Lee had spoken to the land owner who was aware that the Parish Council would be carrying out the work. Cllr J Lee to arrange the mini digger.

Cllrs resolved that the Footpath Warden should inform the Clerk of the costs of repair/maintenance and as long as the costs remain with the budget, could then go ahead.

Raddon Hills also discussed the possibility of employing a Raddon Hills lengthsman. Cllrs were not sure how much Shobrooke would benefit from this, although would like to be kept up to date with the discussions. Cllr C Boult declared an interest in this project. The Housing Bill was also discussed and the potential difficulties that the right to buy might impose on housing stock.

10.1 Playing Field

10.1a To consider latest Inspection Report

10.1b Parking in front of playing field gate

The Clerk had not written to the van owner as, after consultation with the Chair, it was not clear that the vehicle was blocking the gate. In any case it was resolved that no action should be taken as the vehicle was no longer parking in the same position.

A barn owl had been electrocuted on the power lines outside the Church. A parishioner had asked if the Parish Council could write to Wester Power asking if any action could be taken to prevent any further bird strikes on the power lines. **Clerk to action**.

The Chairman read out a report from Cllr M Squires which noted that DCC were consulting again on "Tough Choices" and various meetings were taking place at which the public could give their input. Campaigning for fairer funding for rural education authorities was taking place. Pot holes that are at least the size of a dinner plate across and a depth of 2 inches or more should be reported on line or by phone.
