Minutes of the Parish Council Annual Meeting held on Wednesday 19th May 2021 in the community garden

- 1. Election of Parish Council Chair Cllr Gard was re-elected and signed the declaration of acceptance of office.
- 2. Election of Parish Council Vice Chair Cllr Turrell was re-elected and signed the declaration of acceptance of office.

- Declarations of interest Cllr Dack declared an interest in item 8.5 planning application 21/00807/FULL and Cllr Fisher in item 8.1 planning application 20/01780/FULL
- 5. Election of planning sub-committee Cllrs Wetherden and Brown were re-elected and Cllr Dack was elected, Cllr Howell having stepped down.
- 6. Minutes of the last meeting 17th March 2021 were approved and signed.
- 7. Matters Arising
 - 7.1 Noticeboard

The new notice board is now in situ and has been another successful collaboration with the village hall committee and parishioners. Thanks were given to all the volunteers.

7.2 Howards Copse

There was no further news from Enforcement and to date we have not received a response from Jenny Clifford.

7.3 Devon Climate Declaration

The Hittisleigh Climate Crisis Committee (Cllr Dack, Cllr Brown, Ruth Curtis, Chris Wood) will review the ideas and priorities from the public meeting in 2019 and put forward recommendations for practical action at the next parish council meeting. The group will also review the request to the parish council to consider endorsing the Devon Climate Change Declaration.

7.4 Highways

Cllr Gard gave an overview of Highways issues within the parish for the benefit of DCCIIr Letch noting that there is a real missed opportunity for Highways contractors to join up their efforts with the local road warden to ensure best order of work and best use of funds. Contractors seems to have no recognition of the role of road warden despite it being a DCC Highways scheme. There was much discussion about the deteriorating state of the road from just above Davylands down past Swallow Tree Cross to Spreyton Wood Water and several parishioners have experienced damaged tyres and wheel hubs. It is on the list for repair but no news as to when it is likely to be resurfaced. Cllr Gard will provide DCC Letch with a parish map, highlighted with our highways priorities, with the proposal to then to meet together with the road warden and Steve Tucker (Highways) to visit the areas in person and agree a plan.

- 8.3 20/02084/FULL Erection of log cabin as holiday let and associated shower/wc building woodland at NGR 273448 97276 (north of Teignholt Cross) Treefield Farm withdrawn.
- 8.4 21/00489/CLU Woodside (Colebrooke parish council application for a certificate of lawfulness for the existing use of a dwelling house in breach of agricultural tie condition (g) of Planning Permission 87/02435/OUT for a period in excess of 10 years waiting decision.

Councillors discussed the application and resolved to support it, acknowledging that there is a strong need, particularly in context of covid, for ecofriendly, sustainable accommodation for holidays, such as this will provide.
