Location: Land and Buildings at NGR 285458 108386 (Pt. Cross Farm) Poughill Devon - Poughill Parish Council's response to the consultation request for application 23/00211/FULL is to object for the reason that the case for the condition to be attached under the original permission still stands: ongoing use of the building would require changes in the access to the site which would impact on the surrounding environment. The Council also noted that the building has had a visual impact on surrounding properties which, as the original permission intended, can be addressed if the condition requiring removal is now enforced.
