## 5. Local Elections, 4 May 2023.

#### Parish Council

Information from Devon Association of Local Councils and from Mid Devon District Council had been published and supplied to town/parish councils. As information became available, the Clerk Forwarded, incorporating full set of nomination papers, to Parish Councillors. MDDC has also supplied a copy of a new register of electors to town/parish clerks. The Notice of Election was due to be published on 17 March, it would be posted locally on Parish Council notice board also on local Facebook site. Completed nomination papers to be delivered by hand to the Returning Officer, MDDC, between 20 March and the deadline of 4:00pm on 4 April. The Statement of Persons Nominated for town/parish councils, with contested elections, would be published on 5 April along with those town/parish councils (with equal or fewer candidates than seats up for election) with uncontested election results.

**District Council** 

The Ward, Upper Yeo and Taw, including the parish of Bow, had ben redrawn by the Boundary Commission for England. It would be a two-seat Ward, with the first election on 4 May. The Notice of Election would be published when it became available, on 17 March.

## 6. Coronation of King Charles III, 6 May 2023.

(i) A commemorative Oak tree, 12'-14' high, had been ordered from Bow Garden Centre. It would be collected and planted by the Chairman, at Burston Meadow, on 10 March 2023. The invoice at £300 (£250.00 + vat) had been received. An accompanying plaque would be arranged.

(ii) Bow celebrations. Funding requirements had been requested of the Group but details had not been finalised. To date, a musical event at £120 (other musical items required), portaloos at £295 + vat (a quote for portaloos incl. disability was being obtained), a 6 cu yd skip to ease clearing up at end of the day at £445 incl vat, were to hand. The Group's next meeting was scheduled for 4 April when details of funding requirements would be finalised. The Group did not have a bank account; it was anticipated that Parish Council would pay for items (reclaiming vat). Members briefly discussed funding requirements, but a funding decision could not be made given lack of specific funding requirements in advance (Mrs Hamilton had proposed that £1,500 be granted.)

## 7. Street Name Sign, 'Godfreys Garden leading to Hobbs Way & Lilian Close'.

Delivery vehicle drivers (Amazon, etc) and Royal Mail were confusing Wallens with Wallens Meadow Close, which generated complaints when deliveries destined for Wallens Meadow Close weren't being received. It had been suggested/requested that Mid Devon District Council be requested to amend signage at the entrance to Godfreys Garden to include Wallens Meadow Close. Parish Council agreed that MDDC be so requested.

## 8. D. C.C. Highways Matters.

Speeding A3072 western approach to village (proposed extension of 30mph limit). DCC had not yet made contact. Community Speedwatch (A3072 western approach to village, eastbound traffic). Bow CSW had twice been requested to capture speed data at the western approach, to inform the VAS request. The CSW co-ordinator requested Parish Councillor support with CSW sessions – Parish Council had again been asked about volunteering *Vehicle Activated Speed Sign (VAS)*. Cllr Letch would likely need speed data evidence for VAS request (traffic speed data awaited from Bow CSW). DCC Mid Devon HATOC/SCARF meeting date/info. also required. *Reporting Highways Issues*. Devon's highways team had contacted DALC to highlight the correct way for parish and town councils to report highways concerns which should be channelled through the clerk who may either liaise with the county councillor, report issues directly online, or contact the Neighbourhood Highway Officer. DCC highways team doesn't have capacity to manage additional enquiries from individual councillors. Anyone other than the clerk wishing to report a highways concern could do so online, or by contacting the customer service centre on 0345 155 1004 or csc.roads@devon.gov.uk. Bow Parish Councillors, very aware of local significant pothole issues in Bow, had recently involved local television to highlight the pothole problems, and were not supportive of the advice.

## 9. DCC Report.

Members had been sent a copy of Cllr Letch's March Report. Topics included:-

Upcoming local elections, electors would need to produce photo ID, with advice on how to obtain same, alternatively an application to MDDC for a postal vote obviated the need for photo ID.

DCC Surgeries for parishes would recommence in March, viz.1<sup>st</sup> Saturday Crediton, 2<sup>nd</sup> Saturday Cheriton Bishop and Yeoford, 3<sup>rd</sup> Saturday Copplestone and 4<sup>th</sup> Saturday Bow.

At a Highways meeting, re. potholes, it was noted that summer programmes of road repairs involved 16 gangs but in winter contractors augment the number to 40. A new idea was that during inspections of potholes on the system, inspectors would also mark up nearby potholes needing repair. Reference road closure signage, Cllr Letch had raised a question concerning Road Ahead Closed signs used during a recent Bow closure which had led to motorists' uncertainty/confusion as to which road was closed (a limited number of signs existed for a side road ahead closure).

Car parking charges. Following objections, petitions and cogent arguments, proposed high increases in charges had been halted.
