10. District Councillor Report

DCIIr Colthorpe reported the election results for Mid Devon: 33 Liberal Democrats, 5 Conservatives, 3 Greens and 1 Independent. Mid Devon will be a very different place from the past 4 years which, not to put a fine point on it, have been difficult' because they were 'No overall control', administration took various forms over four years with Bob Deed as Leader, variously supported – initially by the Lib.Dems and the Greens; then by the Conservatives and finally by a coalition of the disenchanted but resigning an hour before the (budget) Full Council meeting in February and succeeded by Barry Warren – who was appointed, not elected to the role for the remainder of the term. Luke Taylor was presently the Lib.Dem leader so might be expected to be the next Leader of the Council but we don't know much more than that, not even whether he proposed to keep the cabinet system – of which, in the past, the Lib.Dems have been highly critical.

Although the rate of inflation is still high, we are happy to report that we have been able to keep the Poughill precept element of your Council Tax for 2023/24 at the same level as it was last year. We would like to thank our residents who give up so much of their free time to help run our local community organisations. The work they do is appreciated by all and goes towards making Poughill such a special place to live in. To assist them with this valuable work we have a small amount of grant funding available this year, which we would encourage them to apply for. Finally, we would like to thank those residents who have attended our council meetings and contacted us with their concerns. We hope we have been of some help. We are looking forward to continuing to represent our residents and doing what we can to improve the well-being of our community over the coming year.
