Item 1.1 Proposals to fill vacancies

Item 5.1: Self build homes at Stonebridge

UPC objected. Nothing further heard.

Item 5.10: Inert Landfill & Waste recycling at Greenway

No further news of this. No application received. Halberton PC has been consulted.

Item 5.11: Meeting Housing Needs: MDDC Affordable housing policy consulation.

Deatils were circulated by email. MDDC's consultation will run from 17 July to 25 August. UPC to consider whether a corporate response is needed.

Item 6.1: Village signs:

Are made. Plan for finishing and erecting them is required. We understand they could be erected as they are and allowed to weather or they could be oiled to enhance the natural colour, The letters could be painted in. U-bolts will be needed to attach them to existing polies.

Item 6.2: Broadband Update

Airband requested to meet with PC. They are unable to make either this meeting or the September date.

Item 6.3: Trim Trail

Is now completed and officially opened. One outstanding invoice of £11490.00 to be paid. Bank statement confirms that VAT refund has been received and funds are thus available.

Congratulations to all who organised this so efficiently.

6.4: Use of grants from parish magazine

The SP & U parish magazine has generously sent us £275 as our grant this year. After paying for the village signs, there will be £250 remaining from last year's grant, making £525 available for discretionary spend. *Decision required on how to use this money.*

6.5: Bus shelter by leat

Paul at the Redwoods asked if UPC might consider a shelter for the Uffculme school students who wait for their bus beside the Leat.

11.1 Railings by leat

Are now completely rotted in places. I have emailed the Highways Officer and will report what he says. Would UPC consider funding replacement?

11.2 Grass in front of Council Houses

Paul at Redwoods asks if the grass area could be levelled/smoothed to facilitate mowing. It is not UPC's property so consultation with MDDC would be needed.
