The application to extend permission for the temporary (caravan) accommodation is to allow extra time for the agricultural business on the site to achieve the commercial viability required to permit the development of a permanent residential building. The application claims that viability has so far been prevented by 'Brexit and the Covid-19 pandemic'. In fact, there are inherent constraints on this business — the indoor rearing of calves - achieving commercial viability: the site is very small (no more than 5 acres) and the current barn housing inadequate for the quantity of livestock required if the business were to be able to demonstrate commercial viability even in the medium term.

Any attempt to meet the business threshold required for securing permission for a permanent residential building will result in a significant expansion of livestock on the site that is not appropriate or sustainable either for the land area or the current barn housing. There is no mains water supply on site and the current operation is dependent upon informal access to a nearby supply. Such intensive agricultural operation on a single field with no supporting infrastructure risks air and environmental pollution and, with high livestock volumes in an enclosed area, further risks to human health and safety. Of course, it also raises animal welfare concerns.

Given the limited area of the single field, any mitigation of these risks would require the development of new barn housing for the livestock of a height, length and breadth which would cause both light pollution and visual impacts to surrounding properties. At any rate, such a development would require Planning Consent.

Therefore, the grounds for objection are that extending the term for temporary accommodation on this site will invite an intensification of the current agricultural operation on a limited land area and infrastructure which are inadequate to support it sustainably, risking air and environmental pollution and human health and safety.
