10. District Councillor/County Councillor Report

10.1 District Report – Budget meeting tomorrow, DCllr Colthorpe happy to support the administration budget, Scrutiny Committee discussed dedicated HR officer retired quite a while ago, not replaced, it was decided to split the job between 3 other officers and a percentage of the salary split, and a percentage put back into the salary budget. Enforcement was discussed, recruiting has been almost impossible, a permanent officer has been put in place.

10.2 County Councillor Report - February 15th saw the agreement at DCC of the 2024/25 budget. 4.99% increase in council tax the majority of which will be for Adult Social Services and Children's services. There are approx. 900 children in care within Devon – many of whom are cared for by foster carers. When you receive your council tax bill this year you will find in the envelope a leaflet about being a foster carer. Devon County are always looking for more foster carers because children are always better in a family setting. Those who are foster carers often find it very rewarding although it can at times prove very challenging.

I was pleased this year that extra money coming to the county council at the last minute resulted in £1.5 million extra being put into highway drainage. Some extra money was also passed on to the district councils to support them with the homeless.

Now is the time to comment on the Devon and Torbay devolution deal and consultation on the proposal to create a Combined County Authority for the area. The CCA is a legal requirement to assume responsibility for new funds and powers transferred by Government from Whitehall to our combined area.
