The purpose of the Steering Group

Legal Framework

- Localism Act 2011
- Power for Parish Councils to produce "local" Neighbourhood Plans.
- Influence development in their area.
- Formal process of inspection and adoption by vote in the community.

National Planning Policy Framework (NPPF).

Neighbourhood plans must have

1. An Economic objective

2. A Social objective

What can it do?

- Set out a shared vision for a Neighbourhood.
- Influence what buildings should look like.
- Propose new sites.
- Influence the types and tenures of new housing.
- Designate public open space.
- Identify transport and infrastructure requirements.

What can't it do?


- Contradict the policies of Mid Devon District Council (MDDC).
- Mandate changes to services which fall outside the remit of the MDDC Local Plan.
- Mandate changes to services outside the NPPF.
- Exert planning powers over areas of activity that are not addressed by the NPPF eg agricultural activity.

Current important dates-MDDC Local Plan.

• Call for sites 2021-completed.

• The outcome of the HELAA process late 2024. Possible implications.

First Meeting 19th of April 2022

Engagement Meetings

- 1. <u>Community Forum Event 25th of February 2023</u>-invite to each household. 58 people attended
- 2. <u>Local children at Newton School age 6-7 and 7-11</u>. 7th of July 2023. Over 91 children consulted.
- 3. <u>Meeting with Businesses and key stakeholders.</u> September 13th 2023.8 stakeholders attended.
- 4. Meeting with MDDC Planning Department.
