6. Actions from June meeting

- 6.1 The Pixie House Parking in front of garage the problem parking is going to need enforcement of some kind if it is to go away but it looks like the police or Highways will need to be involved

10. Allotments.

10.1 Working Group Report – 2 plots have new tenants

10.2 A further discussion was held around the allotment entrance. This encompassed the scope of any future work and the suitability of the entrance for vehicular access. A summary of a discussion with DCC was presented. Further to this concerns remained around suitability particularly due to visibility and agricultural classification, specifically any liability for the council. A request for a written report and opinion to be requested from DCC, if this is not possible a professional opinion should be sought from an appropriately qualified highways professional to fully understand the liability and what can be done to ensure the entrance provides adequate safety for the tenants.' 'A further request was made to consider if a lease agreement should be in place between the owner of the site and the council'

The council has received an email on behalf of the Cheriton Fitzpaine Allotment tenants with regards to the allotment entrance.

It is clear that tenants wish to have safe access to the allotment site with regards to the surface of the entrance, without being in danger of slipping on rough ground. We are looking forward to the final phase of that completion following the remedial work already carried out.

Tenants wish to have vehicular access through the gate to the lower access path in order to deliver heavy items to the site, for example a new shed, bags of compost, an IBC, a rotovator etc, like wise if any heavy items/rubbish need to be removed from the site. (This access should only be necessary for drop-off or pick-up, not for parking). It has come to my attention that some councillors do not wish to allow that facility.

I wish to point out that vehicular access must be allowed for the owners of the land as the adjoining land which is not rented by the Parish Council has no other access, maintenance of trees, hedges and fencing which is not the responsibility of the Parish Council may require large vehicles to enter the site.

Historically there has always been access for vehicles, and at one time the outer access path was accessible enough to allow a tractor to drive to the top of the site (Plot 19) in order to plough over the plots.

I understand the Parish Council would not wish to accept any liability for tenant's vehicles, and it is only right for tenants to accept it is their own responsibility for safely entering and exiting the site. Should it be deemed necessary then it could be written into the Terms and Conditions of Tenancy Agreements.

As the site is purely for horticulture/agriculture it would not warrant the Parish Council spending money opening up the site entrance with a larger splay which is normally required for residential properties. Vehicles will only require access very occasionally for the reasons previously mentioned.

11. District Councillor/County Councillor Report

11.1 District Report – Cheriton Fitzpaine reportedly had 60 incidents of residents leaving side waste out in last year's report, this has reduced to 6 incidents in this year's reports, reorganisation of the planning department means there is now only 2, East and West, MDDC has won 19 awards mostly related to Z Pods and extra housing.

11.2 County Councillor Report – The train station at Marsh Barton is now a year old, Okehampton is to have a new train station, both Crediton and Copplestone have free parking for train users. A discussion was held with DCIIr about the new roundabout in Crediton.
