Item 5.1: Inert Landfill & Waste recycling at Greenway

Revised documents are deposited showing all traffic passing through Uplowman. Details have been circulated to PC. We have not been notified of when the application will be heard. UPC has heard that the Greenway Action Group is thinking about asking Andy Fields to do another dashcam video, or piece of drone footage, to show the route through Sampford Peverell and Uplowman.

Item 5.2: Land behind Stonebridge 23/00684/PIP

A submission was sent to the Inspector. No further news at this stage.

Item 6.1 Redwoods Inn

Item 6.3: Grass cutting

Cllr Adcock to report on arrangements made with local grass-cutters. From Cllr Adcock's email of 29 July: We spoke of what he is able/ would like to continue with reference village grass cutting. He (Mr Hayman) would like to continue to maintain the green opposite the pub and the grass area in front of the ex council houses, but not do the strimming on the leat bank. He has given me a price and regularity for the works.

Apparently, Mr Kidley has turned down management of the leat banks.

Item 6.4: Parish Website

Parishioner Tristan Donald is proposing to set up a website that brings together all Uplowman and Whitnage groups, including UHRA, Church, WI, etc. Meeting was held with interested parties on 27 August, a draft website has been circulated and Tristan is working further on it with objective of finalising by April 2025.
