MINUTES OF A MEETING OF BOW PARISH COUNCIL HELD ON 10 SEPTEMBER 2025 AT 7:30PM IN THE COMMUNITY ROOM OF BOW VILLAGE HALL

1. Public Open Forum.

Two Trustees of Bow Waterworks addressed Parish Council. Mr May, Chairman of the Trustees, outlined the current situation. Bow Waterworks, a charitable trust, currently provided chlorinated water from a borehole. Since March 2025, there had been increasing 'usage' (quantity of water going through the system) of water requiring ongoing increase in pumping hours, currently 21½ hours daily. Users' complaints had been received, the reservoir level had been increased to almost overflowing, to improve pressure and supply, but complaints continued. Much work had been carried out, including by leak detection companies, to try to trace the leak source(s), with varying degrees of success also failure. Leak water was appearing from a BT Openreach chamber in Water Lane but was not appearing up through road tarmac. The leak, indicated to be located in the Square (likely the copper spur pipe connection/spur to Water Lane) would involve a road closure for repair work. Bow Waterworks had encountered difficulties finding accredited contractors who would work with small charities like Bow Waterworks. However, two companies had been identified, one of which had estimated approx. £15,000 to repair the copper spur pipe which crossed the A3072 from the stopcock chamber in the Square. Bow Waterworks' funds were low and several households were understood to be switching their supply to South West Water (thereby reducing future revenue). If the leak continued to worsen, very little time remained available in the 24 hour day to further increase pumping time; continuing at the present rate, in a few weeks pumping requirements could exceed 24 hours a day, making it impossible to operate. Bottled drinking water was delivered, as required. The Bow Waterworks situation was difficult - funds were insufficient to cover the estimated high repair charge. The second contractor had yet to quote/estimate but, it was hoped, it would be less expensive. Parish Council Custodian Trustee discussed, including the future longer-term viability of Bow Waterworks. When current repair work effected and number of properties switching known (some householders were not reporting intentions to switch), the situation would be re-assessed - some re-arrangement of tasks, to involve volunteers, may be necessary. Bow Waterworks Trustee Mr Wyllie commented on the lack of trustees, saying that current difficulties made attracting more trustees difficult. It was possible Bow Waterworks would be sustainable in the future, but unless the current leak was repaired it could not be sustainable. Mr Pengelly recommended that a meeting of all Users be held, providing a forum to discuss matters. A meeting with Users, when all information was available, was intended, however, current antipathy of a few Users towards Bow Waterworks, could make that difficult. Information bulletins on the current situation had been issued to Users, further information would be issued when available. Meanwhile, some householders were refusing to maintain payments of their existing debts. Bow Waterworks was looking for a grant, not a loan, but would only be able to request a specific sum when all estimates/quotes had been received, it was anticipated that information would be available by the following meeting. Trustees were thanked for attending and left the meeting.

Mid Devon District Council had confirmed that that authority had not received any requests for an election, therefore the Casual Vacancy to be filled by co-option. A vacancy Notice had been posted on the notice board and published in the Bow and Arrow.

6. DCC (Crediton Rural Division) Monthly Report.

Cllr Cairney was not present and no report had been received.

7. MDDC (Upper Yeo & Taw Ward) Monthly Report.

Cllr Mrs Letch's report for August-September 2025 had been electronically circulated to Members, email dated 9 September 2025.

State of the District Debate, 17 September. Opportunity for parishes to engage with Local Government Reorganisation. Representatives (large Town and smaller parish) from Somerset would be present and answer questions.

Recycling new targets. Collection of unusable metal pots and pans to commence 15 September. Harder enforcement issues, including littering where FPNS had been issued because black bin bags had been left out more than three calendar days either side of collection. MDDC officers were patrolling known hotspots.

Active Mid Devon. 'Friends that train together, stay together' initiative rewarded members for each friend referred. From 1 September to 30 November all new members referred through the scheme had the joining fee waived https://activemiddevon.com/refer-a-friend-2025

8. Motocross Track, East Langford.

A Planning application for the permanent siting of a motocross track at East Langford, Bow, had been submitted to MDDC in 2021 and subsequently withdrawn. In the absence of formal Planning consent, the 28-day rule applied with exceptions, which included motor cycle racing, reducing to 14 days a year. Local residents had complaints that, since January 2025, the motocross track operators had already, allegedly, exceeded 14 days, with more event(s) planned. It was believed that events had been run on 18-20 days in 2025. Information, including details of operation dates etc had been passed to Ward Members. Cllr White advised that the matter had been raised at MDDC and was being investigated. Mr Steer commented that, in the absence of any Planning consent, the land should be reinstated to farmland.

9. Bow Waterworks, Update on Loss of Water/Leak.

Trustees' information on the situation, with request for funding, refer Item 1 Public Open Forum. It was anticipated that the second estimate would have been received with sum required known by the October meeting.

10. Untaxed Vehicle (silver Volkswagen reg. no. WV55WPO), Jackman Car Park.

Notices had been placed (and frequently removed! indicative of the owner living locally) on the windscreen of the untaxed vehicle. MDDC had been notified in August. Parish Council confirmed that the vehicle needed to be removed by MDDC.

11. Parish Council Computer.

With Windows 10 becoming obsolete in October 2025 (Microsoft would no longer support), recommendations had been that a new laptop, with Windows 11, be acquired. Mr Paul Edworthy (Edworthy Media) said+ that, otherwise, security issues could be experienced. Members agreed that a new laptop be acquired and requested that prices be obtained.

12. Local Government Reorganisation, English Devolution White Paper.

A Devon Association of Local Councils (DALC) remote (via Zoom) Connect Event, entitled LGR - What can you do now? preparing for asset and service devolution, had been held that day, with some 40 attendees. The main speaker, Mr Carl Hearn, Clerk at Tavistock Town Council and a former joint governance lead at Cornwall Council at the time of their unitary authority transition, had delivered a presentation. He was very experienced, knowledgeable and impressive, answering multiple questions. Covered were the possible options and bids which had, thus far, been put forward. The new arrangement would not be straightforward; it would be a new way of working, with the Principal Authority (PA) Assets and Services to be considered; statutory services (libraries, highways, children) would remain the PA's responsibility, discretionary services would need to be looked at, any with income generation would be likely to remain with the PA.

The event was recorded; the session with presentation slides would be available and circulated to Members. MDDC's State of the District Debate, to be held at Phoenix House, Tiverton, on 17 September, would focus on Local Government Reorganisation. Two representatives from each town/parish council had been invited. The Clerk hoped to attend.

13. D.C.C. Highways Matters.

Speeding A3072 western approach to village (DCC suggested highway works), Burston Cross area. Still nothing had been received or heard from DCC. In readiness for Cllr Cairney's meeting with DCC Neighbourhood Officer 10 July, the Clerk had emailed details of outstanding issues and actions required. However, response was inconclusive. Vehicle Activated Speed Sign (VAS). Nothing had been heard or received from DCC. The July meeting between Cllr Cairney and Mr Tucker yielded a response advising that Mr Tucker "agreed to 30mph speed limit outside Bow but that he felt that undergrowth should be cut down first so the sign is more visible". Clarification/confirmation was required.

Other Highway matters. No other issues raised.
