Public Participation: Posters advertising a fireworks display are repeatedly being removed from the village. The Bonfire Committee expressed its frustration.

- 1. Present Cllr Dibley (Chair), Cllr Acton, Cllr Frost, Cllr Steale, Cllr Harlow, Cllr Cooke, DCllr Colthorpe.
- 2. Apologies Cllr H Kingdon.

3. Co-Option of Councillor

- 3.1 Joanne Williams Was co-opted as a new councillor after confirming eligibility and completing paperwork Proposed Cllr Cooke, Seconded Cllr Frost, all agreed.
- **4. Minutes -** It was agreed to approve the Minutes for the October meeting. Proposed Cllr Frost, Seconded Cllr Harlow, all agreed.
- **5. Declaration of Interest** Cllr Dibley declared an interest in 8.3.

5. Actions from September meeting.

- **5.1** State of the District Debate Cllr Cooke attended the meeting, the discussion was mostly about local councils potentially taking on more responsibilities from county councils, with a suggestion to consider increasing the precept to prepare for this.
- **5.2** Speed Watch Surgery held on 11th October Cllr Dibley and Cllr Kingdon were in attendance, Feedback indicated speeding is less of a concern than road conditions and white lines, ongoing frustration with the slow pace of road repairs and missing white lines. Residents were encouraged to report issues online to increase pressure for action. Speed Watch has been put on hold.
- **5.3** Meads Meadow The council discussed quotes for new play equipment for young children. The initial quote was considered high, so more quotes will be sought at a later date.
- **5.4** Millenium Stone Still uncertainty about land ownership, CCllr Keeble meeting with Steve Tucker on the 07th of November, he will ask the question of who owns the land. Cllr Dibley has received a quote for a 12ft tree delivered to Cheriton £70.00, light £60.00, quote has been accepted.
- **5.5** Community Herb Garden The proposed location has been considered too shaded. Alternative, sunnier locations were discussed, Cllr Steele has suggested putting the herb garden by the bench near the school entrance, Cllr Steele will bring additional information to the next meeting.

6. District Councillor/County Councillor Report.

- **6.1** District Councillor Report An enquiry has been made as to what is happening to the houses at Wordland Cross, the portfolio holders have changed since the county elections, some of the people who were the portfolio holders became county councillors as well and then found themselves with too much to do, so there was a reshuffle at Mid-Devon of portfolio holders and the portfolio holder who is now property, assets and public service is Jane Locke. DCllr Colthorpe has given Jane a brief format.
- **6.2** County Councillor Report A pilot scheme is being carried out in terms of the potholes, potholes are being treated in that they're looking at them and surveying 500 metres either side of the pothole. That pilot scheme is being evaluated this month, monthly report attached.
