## 7 PLANNING APPLICATION (17/00980/FULL) - Change of use of agricultural land to domestic garden and erection of garden shed, at Land and Buildings at NGR 284792 111021 Chapple Farm Pennymoor Devon.

**Proposal:** Mr Berry proposed and Mr Hall seconded agreement to this application and the meeting unanimously agreed.

## 8 PLANNING APPLICATION (17/01137/FULL) – Erection of an agricultural building for the storage of farm machinery, production of honey and fruit preserves at land at Allberry Farm, Pennymoor.

A lengthy discussion took place and concerns were raised about the size of the building in relation to its proposed use.

**Proposal:** Mr Hall proposed and Mr Lake seconded agreement to this application but with the following comment and the meeting unanimously agreed.

What is the justification for such a large building for the purpose stated especially as there is currently no knowledge of such a business taking place at this location. There is no objection to a building being erected but suggest a
